- Cov ntawv teev nyiaj tau los yog cov ntawv W2 rau txhua txoj hauj lwm
- Tag nrho cov ntawv 1099 uas tau txais
- Cov nyiaj tau thaum xyoo kawg ntawm MFIP, SSI, MSA, GA, cov nyiaj pab qub tub rog, cov nyiaj rau neeg ua hauj lwm raug mob
